

ORDINANCE NO. 422

AN ORDINANCE OF THE TOWNSHIP OF SPRING, BERKS COUNTY, PENNSYLVANIA, AMENDING THE TOWNSHIP OF SPRING CODE OF ORDINANCES, CHAPTER XIX ENTITLED "MOTOR VEHICLES AND TRAFFIC", PART 2 ENTITLED TRAFFIC REGULATIONS BY: (1) SUPPLEMENTING SECTION 202 ENTITLED "SPEED LIMITS ESTABLISHED", TO RATIFY EXISTING 25 MPH SPEED LIMITS ON CONNEL DRIVE BETWEEN BROADCASTING ROAD AND WEST THISTLE DRIVE, ON CROMWELL DRIVE BETWEEN ETHAN DRIVE AND WESTWOOD ROAD, ON EAST THISTLE DRIVE BETWEEN ETHAN DRIVE AND WEST THISTLE DRIVE, ON ETHAN DRIVE BETWEEN PAPER MILL ROAD AND EAST THISTLE DRIVE, ON SHERWOOD DRIVE, ALSO KNOWN AS, SHERWOOD ROAD BETWEEN WESTWOOD ROAD AND EAST THISTLE DRIVE, AND ON WEST THISTLE DRIVE BETWEEN EAST THISTLE DRIVE AND ETHAN DRIVE; AND (2) SUPPLEMENTING SECTION 205 ENTITLED "STOP INTERSECTIONS ESTABLISHED", TO ESTABLISH A STOP INTERSECTIONS ON CONNEL DRIVE AT THE INTERSECTION OF BROADCASTING ROAD TRAVELING WEST, ON CROMWELL DRIVE AT THE INTERSECTION OF ETHAN DRIVE TRAVELING WEST, EAST THISTLE DRIVE AT THE INTERSECTION OF ETHAN DRIVE TRAVELING NORTH, ON ETHAN DRIVE AT THE INTERSECTION OF EAST THISTLE DRIVE TRAVELING EAST AND SOUTH, ON ETHAN DRIVE AT THE INTERSECTION OF PAPER MILL ROAD TRAVLING NORTH, ON ETHAN DRIVE AT THE INTERSECTION OF WEST THISTLE DRIVE TRAVELING WEST, ON SHERWOOD DRIVE AT THE INTERSECTION OF EAST THISTLE DRIVE TRAVELING WEST, ON WEST THISTLE DRIVE AT THE INTERESTION OF CONNEL DRIVE TRAVELING NORTH AND SOUTH, AND ON WEST THISTLE DRIVE AT THE INTERSECTION OF ETHAN DRIVE TRAVELING SOUTH

BE IT ENACTED AND ORDAINED, by the Board of Supervisors of the Township of Spring, Berks County, Pennsylvania (the "Township"), and it is hereby ENACTED AND ORDAINED by the authority of the same as follows:

**SECTION 1.** Section 202 entitled "Speed Limits Established", of Part 2 entitled "Traffic Regulations", of Chapter XI entitled "Motor Vehicles and Traffic", of the Township of Spring Code of Ordinances, is hereby supplemented by adding thereto and ratifying the following speed limits on the streets designated:

<u>Highway</u>	<u>Between</u>	<u>Speed Limit</u>
Connel Drive	Broadcasting Road and West Thistle Drive	25 mph
Cromwell Drive	Ethan Drive and Westwood Road	25 mph

East Thistle Drive	Ethan Drive and West Thistle Drive	25 mph
Ethan Drive	Paper Mill Road and East Thistle Drive	25 mph
Sherwood Drive and Sherwood Road	Westwood Road and East Thistle Drive	25 mph
West Thistle Drive	East Thistle Drive and Ethan Drive	25 mph

**SECTION 2.** Section 205 entitled "Stop Intersections Established", of Part 2 entitled "Traffic Regulations" of Chapter XIX entitled "Motor Vehicles and Traffic", of the Township of Spring Code of Ordinances, is hereby supplemented by adding thereto the following stop intersections:

<u>Stop Highway</u>	<u>Through Highway</u>	<u>Direction of Travel</u>
Connel Drive	Broadcasting Road	West
Cromwell Drive	Ethan Drive	West
East Thistle Drive	Ethan Drive	North
Ethan Drive	East Thistle Drive	East
	East Thistle Drive	South
	Paper Mill Road	North
	West Thistle Drive	West
Sherwood Drive	East Thistle Drive	West
West Thistle Drive	Connel Drive	North and South
	Ethan Drive	South

**SECTION 3.** The provisions of this Ordinance are severable, and if any section, sentence, clause, part or provision hereof shall be held to be illegal, invalid or unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect the remaining sections, sentences, clauses, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Township that such Ordinance would have been enacted if such illegal, invalid or unconstitutional section, sentence, clause, part or provision had not been included herein.

**SECTION 4.** The Code of Ordinances, as amended, of the Township of Spring, Berks County, Pennsylvania, shall be and remain unchanged and in full force and effect except as amended, supplemented or modified by this Ordinance. This Ordinance shall become a part of the Code of Ordinances, as amended, of the Township of Spring, Berks County, Pennsylvania, upon adoption.




**SECTION 5.** All ordinances or parts of ordinances of this Township which are inconsistent herewith are hereby repealed.


**SECTION 6.** This Ordinance shall become effective at the earliest date permitted by law following the date of its enactment.


